DGP Ranking: TPA Poland among the leaders of the Largest tax advisory firms

The 16th edition of Dziennik Gazeta Prawna's ranking of companies and tax advisors has just been resolved. For another year in a row, TPA Poland was ranked among the Largest tax advisory firms in Poland.

In the ranking of Large Firms, TPA Poland placed 3rd in terms of revenue (it was 4th a year ago), recording a more than 15% year-on-year increase in revenue, and 4th in terms of the number of professionals and the number of tax advisors. The company also recorded the second highest revenue per single client in this group (calculated as total revenue against the number of clients).
